

**VILLAGE OF MISHICOT
WELL OPERATION PERMIT**

This permit is granted to the undersigned private well owner to operate a well for a period not to exceed five (5) years providing the conditions of this section are met. The owner may request renewal of a well permit by submitting information verifying that the conditions of this section are met. The Utility Board, or its agent, may conduct inspections or have water quality tests conducted at the applicant's expense to obtain or verify information necessary for consideration of a permit application or renewal

The following conditions must be met for issuance of a well operation permit:

- (1) The well and pump installation meet or are upgraded to meet the requirements of CH. NR 812, Wisconsin Administrative Code and has to be inspected by pump installer or well driller, etc.
- (2) The well construction and pump installation have a history of producing bacteriologically safe water as evidenced by at least two (2) samplings taken a minimum of two (2) weeks apart and no longer than four (4) weeks apart. No exception to this condition may be made for unsafe wells unless the Department of Natural Resources approves in writing the continued use of the well.
- (3) There are no cross-connections between the well and pump installation and the municipal water system, and no unmetered well water shall discharge into the sanitary sewer system. A one quarter inch tap is allowed inside the owners dwelling for the sole purpose of water sampling of the well. This tap shall be a smooth end. A threaded private well faucet end or having any threaded ends in the line from the well piping inside the dwelling is illegal and must be corrected by having permanent connections replacing all the threaded ends.
- (4) The purposed use of the well and pump installation can be justified as being necessary in addition to water provided by the municipal water system, such as for washing car, watering gardens and lawns, etc.
- (5) Any well owner allowing the well permit to expire shall be fined Fifty (\$50.00) Dollars (plus any other applicable costs) for each calendar day the well permit is in non-compliance.

(6) WELL OPERATION PERMIT. The Director of Public Works may grant a permit to a private well owner to operate a well for a period not to exceed five (5) years providing the conditions of this section are met. An application fee, in an amount to be set by Resolution of the Village Board and which may be changed from time to time, must be paid to the Village of Mishicot when the well application permit is filed with The Director of Public Works. An owner may request renewal of a well operation permit by submitting information verifying that the conditions of this section are met. The Village, or its agent, may conduct inspections or have water quality tests conducted at the applicant's expense to obtain or verify information necessary for consideration of a permit application or renewal. Permit applicants and renewals shall be made on forms provided by the Clerk. The following conditions must be met for issuance or renewals of a well operation permit:

- (a) The well and pump installation meet or are upgraded to meet the requirements of CH. NR 812, Wisconsin Administrative Code.
- (b) The well construction and pump installation have a history of producing bacteriologically safe water as evidenced by at least two (2) samplings taken a minimum of two (2) weeks apart and no longer than four (4) weeks apart. No exception to this condition may be made for unsafe wells unless the Department of Natural Resources approves in writing the continued use of the well.
- (c) There are no cross-connections between the well and pump installation and the municipal water system. A one quarter inch tap is allowed inside the owners dwelling for the sole purpose of water sampling of the well. This tap shall be a smooth end. A threaded private well faucet end or having any threaded ends in the line from the well piping inside the dwelling is illegal and must be corrected by having permanent connections replacing all line threaded ends.
- (d) The proposed use of the well and pump installation can be justified as being necessary in addition to water provided by the municipal water system.
- (e) Any well owner allowing the well permit to expire shall be fined \$50.00 (plus any other applicable costs) for each calendar day the well permit is in non-compliance.
