## ORDINANCE 2023-04 VILLAGE OF MISHICOT

AN ORDINANCE TO AMEND THE CODE OF THE VILLAGE OF MISHICOT BY DELETING AND REPEALING VARIOUS CHAPTER SECTIONS "VIOLATIONS AND PENALTIES" AS SHOWN BELOW THEREOF, AND REPLACING IT WITH STANDARD LANGUAGE, "VIOLATIONS AND PENALTIES" WHICH CHAPTER SECTIONS PROVIDE FOR GUIDELINES IN REGARDS TO VIOLATIONS AND PENALTIES WITHIN THE VILLAGE LIMITS.

It is hereby ordained by the VILLAGE OF MISHICOT, Manitowoc County, Wisconsin, as follows:

§115-10(B) is amended to read as follows: Any person, partnership or corporation who or which violates any provision of this chapter shall be subject to a penalty as set forth in §1-2 of the Code. A separate offense and violation shall be deemed committed on each day on which a violation occurs or continues to occur.
