Resolution No. 2021-001

RESOLUTION TO ADOPT WARD PLAN AND TO COMBINE WARDS FOR VOTING PURPOSES

WHEREAS, Wis. Stat. §5.15, requires all cities, villages, and towns with a population of 1,000 or more to establish municipal wards based on the results of the decennial census; and

WHEREAS, Wis. Stat. §59.10(3)(b) requires that each county board adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan, dividing the county into districts and designating the approximate location and population of each ward proposed to divide the county into districts; and

WHEREAS, the Manitowoc County Board of Supervisors has submitted such a tentative Manitowoc County Supervisory District Plan to the Village of Mishicot, and; the Village of Mishicot has received the tentative plan; and

WHEREAS, the Wisconsin Statutes require that each municipality designate by consecutive whole number, geographical description, and population the various wards to be created within the municipality; and

NOW, THEREFORE BE IT RESOLVED, that the Village of Mishicot adopts the wards described as follows:

BE IT FURTHER RESOLVED, that Wards 1 and 2 created above are hereby combined for voting purposes; and

BE IT FURTHER RESOLVED, that the designated polling place for Wards 1 and 2 is the Mishicot VFW Hall, 314 W Main St, Mishicot, WI 54228.

BE IT FURTHER RESOLVED, that upon passage, a copy of this resolution shall be filed with the Village clerk, who shall transmit a copy of the ward plan and this resolution to the County Clerk within five days of its adoption and that this resolution shall remain in effect for each election until modified or rescinded in accordance with Wisconsin Statutes, or until a new division is made following the next federal decennial census.




