Home Delivered Meals & Dining for Seniors

Manitowoc County offers a wonderful service to eligible individuals that many may not be aware of, a delicious, hot home delivered meal. Home Delivered Meals are available anywhere in the County. In Mishicot and its surrounding areas meals can be delivered up to 5 days a week. Eligibility guidelines are as follows:

- A person aged 60 years of age or older who is frail and essentially homebound (does not leave home under normal circumstances, flexibility is allowed for appointments), or a spouse of an eligible person regardless of age or condition.
- A disabled individual who resides at home with an eligible older individual participating in the program.

A dining site is also located at the Mishicot Vets Club where meals are served Mondays, Wednesdays and Fridays to anyone 60 years of age or older and their spouse regardless of age.

Meals are available to all qualifying individuals on a donation basis regardless of income.

Historic Mishicot Homes

Historic Mishicot Homes 6th installment (*Contributed by Jim Sustman*) 315 Spruce Street

The Peter Rau House, located at 315 Spruce Street, across from our Post Office, is commonly referred to as a commercial style home. It was built c. 1870 by Peter Rau, who was born in Germany in 1833 and came to Mishicot in 1848. Here he married Catherine Scheuer, daughter of Nic Scheuer. Together they had six children, all of whom were raised in this

house. Peter ran a successful mill in the village, in addition to the mill started by Daniel Smith.

This house of brick followed a number of other brick buildings in the village built around the same time. The first of record was the Bader Hotel (now Cozy corner) built in 1868. Mishicot's first school house, built in 1849, was located at the base of the cemetery hill. When it became overcrowded, the local school board held many meetings to discuss the building of a second schoolhouse. Because Peter Rau was a member of the school board, many of those meetings were held in the Rau house. Eventually, construction of Mishicot's second schoolhouse, a two room building, was completed in 1873 and that building serves today as our museum and research center.

In 1883, the Rau family moved from their house in Mishicot to Two Rivers, where Peter went into the hotel business, operating the Lake House. Over the years since then, the Rau house has been occupied by many different owners, including one for whom it served as a business called The Doll House. Currently it is owned by a party in Two Rivers and is for sale. Its downtown location could serve well for a small business.

FROM THE CLERK'S OFFICE ... WISCONSIN VOTER PHOTO ID IS HERE!!

I am very happy to say that the citizens of the Village of Mishicot have done a fabulous job adjusting to voter registration since its incorporation in 2006. Yes, it really has been ten years! As you know, Voter Photo ID has been passed into law. In addition to voter registration, we must now prepare for Voter Photo ID. Voter Registration and Voter Photo ID are two completely separate matters. As has been the case since 2006, you will still need to show proof of residence to register to vote should you be a new voter, have a change of address, or a change of name, or if you haven't voted in more than four years and have been removed from the voter registration system. If you are properly registered and are on the poll book, you do not need to present proof of residence at an election.

Voter Photo ID is very different from showing proof of residence to register. Voter Photo ID is something you will have to do for every election, every time you need a ballot. For most people, their Voter Photo ID will be a Wisconsin DOT-issued Driver's License, a Wisconsin DOT-issued ID card, a Military ID card, or a US Passport. All must be unexpired or expired after the most recent general election (currently November 4, 2014). There is no formal Wisconsin Voter Photo ID card. The address on your ID does not have to be current. Election officials will only look at your ID type, name, picture, and expiration date. Your name must only conform to your name in the poll book; it does not have to be identical.

There are other acceptable photo ID's. If you are a village resident and need help determining if you have what you need, please contact me as soon as possible for assistance so that you have time to obtain what is needed before Election Day if necessary. Free ID's are also available from the Wisconsin DOT if you happen not to have an acceptable form of photo ID, but it must be applied for in advance.

Absentee ballot requests by mail or email must be accompanied by a photocopy of an acceptable form of voter ID. This will be required only the first time you ask for an absentee ballot by mail, unless you have had a change in name or address. In-person absentee voting in the Clerk's Office will always require presentation of a photo ID, just like at the polls.

There are some voters who are exempt from the Photo ID law. They are as follows: military voters; voters who are permanently overseas; confidential voters; indefinitely confined voters; nursing home and care facility residents.

Under the law, all in-person voters must present photo ID. Please do not ask the poll workers to waive the requirement because they know who you are. In fairness, all voters must be treated exactly the same way. I ask for your patience with me and your poll workers as we implement the new law. You may also find changes at the polling place as we adjust to accommodate you. If you are a village resident and have questions or need help determining if you have what you need to vote, please call my office at 755-2525.

I will be making brochures available in the village in the coming months with more detailed information. You will also find detailed information about the Voter Photo ID law by visiting bringit.wi.gov or mishicot.org under Local Government. Mishicot Maintenance-Snow Removal

Hello to all Village of Mishicot property owners. Many questions have come up regarding snow removal policies within the Village of Mishicot. We really got hit with a big heavy storm after Christmas. The following is the village's ordinance concerning sidewalk snow removal.

6.08 Snow and Ice Removal. (1) From Sidewalks. The owner or occupant of any lot abutting on a public sidewalk shall clear the sidewalk of snow within 24 hours after a snowfall and keep the same free of ice. If such snow or ice is not removed as required herein the Public Works Supervisor shall cause same to be done and the cost thereof assessed against the abutting property pursuant to Section 66.60(16), Wisconsin Statutes. (12-03-96)

I would like to add that the entire width of the sidewalk should be cleared.

(2) **Deposit in Streets Prohibited.** It is unlawful for any person in clearing snow from parking lots, driveways, filling stations, garages, retail stores, apartment buildings, or other areas to pile or distribute snow, or cause snow to be piled or distributed, in a street or alley in any manner that tends to narrow the traveled portion of the street, prevent parking at the curb, or in any other way impede snow removal or create a traffic hazard. Persons having an accumulation of snow that cannot be removed as set forth in the Section shall be responsible for its handling at their own expense without depositing same in the public streets or alleyways. (12-03-96)

Another concern that comes up is in what order the streets get clear of snow. This depends on the amount of snow and the timing of the storm. If the storm is four inches or less and is done by the late evening or early morning hours, all streets are completely cleared by 6:30 a.m. the following morning. If this same size storm continues throughout the morning hours, the heavily traveled streets and school bus route streets are cleared off by 6:30 a.m. to 7:00 a.m. Depending on the amount of snow that will continue to fall throughout the morning these same streets may only have the driving lanes cleared until the storm is over. We have three designated snow clearing routes having three pieces of equipment that are used. Each piece of equipment is best suited to remove street snow in certain designated areas to get the job done as efficiently as possible. Once it is decided that all streets are to have snow cleared, each designated route has a pattern to follow going from one street to the next so that time is not wasted jumping around from street to street. The clearing of snow in front of the ambulance and fire department is included as a high priority.

If we get an extremely large storm like we did after Christmas we do the best to open up the streets that have higher traffic volume. If it is possible we clear the snow off all the streets during the storm so that when the final clearing is done it is a little bit easier to clear the snow. During this last heavy storm this action was not taken because of safety issues concerning parked cars and visibility and the timing of the storm. It took us all of 13 hours to clear all streets from this large snowfall. The one ton truck was too light to move any snow on most streets. The tractor was too light to move snow with the existing 12 foot snowplow so the bucket was put on to open up certain areas down to the pavement. We will be looking at correcting the tractor snowplow size in the future. The International Truck with chains on all tires and seven yards of sand/salt mix for weight was the only piece of equipment that could remove snow in a timely manner.

Another question that comes up often is snow removal on Main Street. It is our policy to generally remove snow on East Main Street first taking the snow from the northeast side and pushing it to the southwest side. We never leave the site having any driveways blocked. If you need to leave during this snow removal, contact the tractor operator and he will gladly open up access to your driveway. The second stage of snow removal is South Main Street from the park and fire station to designated curbed area south of East Church Street. During the time of Main Street snow removal, a maintenance employee is clearing all public sidewalks from snow including the Riverwalk.

The snowstorm after Christmas was one of the most difficult storms since I started working for the village back on January 1st, 1985. The ground was extremely soft and some sod was dug up. We will make all repairs next spring. Also during the time clearing snow after the major storm, your three maintenance people worked 13 to 14 hours each day for 3 consecutive days to provide safe streets. For reasons of employee fatigue and safety we did not work longer hours. The maintenance department has two very recently hired employees, John Tulachka and Adam Schanilec. They're doing a



great job and will give you many good years of service. Both are easy to work with and take their responsibilities very seriously.

Remember that Manitowoc County clears snow on Hwy B, Hwy 147 and Randolph Street. Complaints in this area should be directed to Manitowoc County.
