Regular Meeting March 5, 20019

The March 5, 2019, regular meeting of the Mishicot Village Board was called to order by President Samz at 7:00 p.m. in the village hall. Roll call indicated Trustees Valenta, Scheuer, Kliment, Haack, Franz and Krause were present. Chief Paul Granger and John Tulachka were also present, as well as Al Beranek, Ivan Konsela and Taryn Nall.

President Samz led all those in attendance in the Pledge of Allegiance.

Trustee Kliment moved to approve the minutes of February 19, 2019 meeting as posted. Motion seconded by Trustee Krause. Motion carried.

Taryn Nall distributed a packet of information regarding the E. Church St. Project.

Trustee Krause reported that the Progress Lakeshore Bi-Monthly Report will remain on the agenda for March 19, 2019.

President Samz introduced general fund claims in the amount of \$89,058.84, water utility fund claims in the amount of \$13,594.80, and sewer utility fund claims in the amount of \$14,384.78 for Board action. A motion was made by Trustee Franz to accept the claims as presented and posted. Motion seconded by Trustee Scheuer that claims totaling \$89,058.84 be approved and the Treasurer be authorized to issue same. Roll call indicated as follows: Ayes - 6; Nays - 0. Motion carried.
