The September 15, 2020 meeting of the Mishicot Village Board was called to order by President Samz at 7:00p.m. at the Village Hall. Roll call indicated Trustees Becker, Beranek, Ferry, Haack, Kliment, and Samz. Trustee Franz was absent and excused. Paul Granger and John Tulachka was also present. Also, in attendance was Dale Coenen and Ken Heyroth.

President Samz led everyone in attendance in the Pledge of Allegiance.

A motion was made by Trustee Kliment to approve the September 1, 2020 regular meeting minutes and the September 9, 2020 special meeting minutes, seconded by Trustee Beranek. All in favor, motion carried.

Dale Coenen was concerned about the length of time that the work being done by Northern Pipe on Church Street and the cost.

Chief Granger spoke about the Kickin Addiction kickball event and the Boy Scouts Bike Rodeo.

John Tulachka reported that Matt's Services repaired 3 residential shut-offs and also fixed 2 storm sewer main pipes as the joints were off set. State Athletic Champion's sign will be put up this week on Washington Street. There is a water leak in the lateral that goes to the Park Building and Matt's Services will be doing the repair on Park Lane.

Trustee Ferry has a zoom meeting for Progress Lakeshore.

Village Board discussed about having Trick or Treat on Saturday October 31 from 5:00p.m. until 7:00p.m. but will discuss further at the October 6, 2020 Village Board Meeting.

A motion was made by Trustee Kliment to approve comp time for the Administrative Assistant position for anything over 32 hours, seconded by Trustee Ferry. Roll call indicated as follows: Ayes -6: Nays-0; Absent-1 motion carried.

Budget Committee will meet on Tuesday October 20, 2020 at 6:00p.m. at Village Hall.

A motion was made by Trustee Kliment to approve the Certified Survey Map for Douglas Gnadt, seconded by Trustee Becker. All in favor, motion carried.
